## CONDITIONS OF AFFILIATION

1. The college should have a qualified Principal.
2. HOD for PG Department should be a Ph.D. holder. (Retired persons only up to 64 years)
3. For all the proposed new programme, the qualified faculty members should be appointed as per UGC norms and direction of the High Court.
4. To verify the availability of qualified faculty staff members, the University may visit the colleges at any time.
5. The College shall implement all the recommendations stipulated by the Inspection Commission.
6. The College shall have permanent building and sufficient accommodation available for the proposed new course(s).
7. The number of students that may be admitted to the course shall not exceed the sanctioned strength.
8. Library and Laboratory shall be equipped as recommended by the commission.

9. Required number of Staff as recommended by the Commission with necessary qualification prescribed by the University shall be appointed before the commencement of the course.
10. The college shall make all arrangements for the smooth conduct of the University Examinations.
11. The college shall renew the Provisional Affiliation every year.
12. The Management/Educational Agency shall not collect Capitation fee/Donation in any name for any purpose in any manner.
13. The intake of students for the course shall be filled-in strictly according to the guidelines and rules and reservation issued by the Government time to time.
14. The College shall not admit students in the First Year of the programme without obtaining Continuance Provisional Affiliation from the University for every academic year.
15. The college shall pay the salary to the staff through the bank.
16. The college shall collect Tuition and other fees from the students as prescribed by the Government/University from time to time.
17. The College shall conduct the classes in the evening, only if affiliation is granted for evening courses and timing of day college shall not clash with that of evening college.
18. The College shall follow all guidelines/procedures issued by the Government of Tamil Nadu and this University with regard to admission of candidates.
19. Such other condition as may be prescribed from time to time by the University shall also be complied with.
20. The college should strictly adopt the Tamil Nadu Government Higher Education (E1) Department G.O. Ms. No.107 dated 14.05.2015 while filling the Teaching & Non-Teaching vacancy.

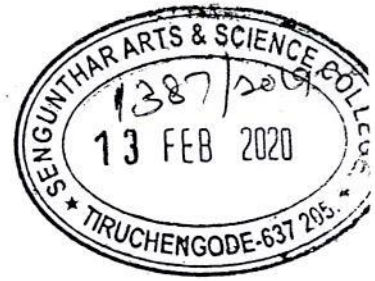

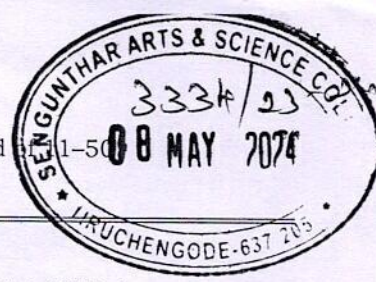


